#### **DELIVERY INSTRUCTIONS**

Dear Sirs / Madams

In order to ensure a safe, smooth and effective process flow in the fully-automated warehouse area of our company and to avoid unnecessary costs, subsequent queries, delays or unwanted returns, we request that you fully comply with the following instructions for each delivery.

Any agreements deviating from these instructions must be made in writing and must also be agreed by the ZWILLING goods-in department. The respective current version of our delivery instructions shall apply.

#### 1. DELIVERY ADDRESS

The relevant delivery address is included in the order and must be used.

#### 2. GOODS ACCEPTANCE TIMES

Mon. – Fri. 08:00 – 17:00 PM Sat. 08:00 – 12:00 PM

Deliveries made outside these specified acceptance times, must be arranged in advance by telephone with the goods-in department.

In principle, we ask for notification <u>two working days in advance</u> for a delivery volume <u>of</u> more than 4 Euro-pallets in order to agree on a delivery date.

No goods are accepted without the express consent of the goods-in department.

#### 3. GOODS-IN INSPECTION

The goods-in department compiles inspection reports and fault lists.

We hereby expressly point out that we reserve the right to invoice you for any costs, damages and losses incurred due to the non-observance of these delivery instructions in the form of processing fees and in accordance with the itemization attached as Appendix 1.

We further reserve the right to totally refuse acceptance of deliveries with serious faults which are identifiable for us upon delivery.



# PACKAGING, DELIVERY NOTE AND LABELLING

In principle, delivery on undamaged and exchangeable Euro pallets is desired. Alternatively, delivery on slip-sheets is also possible for container deliveries. In the case of delivery of entire containers, loose master carton loading may also be possible.

#### For delivery on pallets:

- The load must not protrude either in height or over the palette surface and must not be packed so that it slopes.
- All pallets must be wrapped in transparent film and additionally secured with plastic straps to avoid the goods tilting or slipping during transportation by HGV or during any materials handling processes.
  - Please also note that no film edges or similar should jut out.
- For piece good shipments, in order to protect the goods, every package must be wrapped in plastic strapping bands in order to avoid unauthorized access.
- Every pallet and every other package must be delivered as single-product types and be furnished with a pallet slip (see the example in Appendix 4). Here the number of packages should be kept as low as possible through efficient packing. However, as a rule the weight of each package may not exceed 25 kg.
- Mixed pallets are only permitted if, for quantity reasons, a single-product type delivery is not economic.
  - Example: For delivery of 1 pallet with 3 different items, see Appendix 4.
- The same packaging units must contain equal quantities of individual items.
- Small quantities can be consolidated into one packaging unit provided that each subpackaging unit is labelled accordingly.
- Each sub-packaging unit must be labelled with a content list and the ZWILLING item number and number of pieces.
  - Example: Package contains 300 pieces of Item XXXXXXX, packaged in 25 smaller cartons each with 12 pieces. The large package must display: Item Number XXXXXXX Total Number of pieces 300 consisting of 25 x 12 pieces. The internal smaller packages must then be labeled with Item Number XXXXXXX 12 pieces.
- The pallet must be packed so that it can be easily counted from the outside.
  To do this, the item numbers must be arranged so, that they face outwards of the packaging.
- Identical items should be distributed over as few packages as possible. For example: order quantity 150 pieces, carton quantity: 68 pieces → 2 full cartons and one break-open carton. For volume reasons, it is permitted to fill up this break-open carton with additional items.

- \* Corresponds to the optimum loading height (including pallet) for storage at the site. After consultation, a loading height of 2.20 m is possible in order to achieve optimum container utilization.
- \*\* In case of delivery on a 'EUR 2' pallet:
  - this may only be made on flawless, undamaged and exchangeable Europool wooden pallets.
  - the pallets have to be heat-treated fumigation to lower risk of mold and harmful insects
  - Zwilling does not maintain a separate pallet account for individual suppliers.

#### 4. DELIVERY NOTE AND LABELLING

A separate delivery note must be created for each delivery and attached in a delivery pouch on the outside of the goods.

Ideally, the delivery note uses the layout as shown in our sample attached as Appendix 6. However, it **must necessarily** contain the following information:

- 1. The full name and address of the supplier and the name and direct dial of the contact person.
- 2. The ZWILLING supplier number.
- 3. The delivery note number.
- 4. The ZWILLING purchase order number and purchase order date.
- 5. The ZWILLING purchase order items.
- 6. The ZWILLING item description and ZWILLING item number.
- 7. Delivery quantities.
- 8. Number of Euro pallets, packages, grid boxes etc.
- 9. The dispatch date.
- 10. Batch number where available.
- 11. In the event of differences between the original order quantity and the actual delivery quantity, the label must state the following:



"T" for partial delivery

"R" for remaining delivery

"M" for short delivery

"**UE**" for over-delivery

In the near future it is planned to map the delivery as DESADV (Despatch Advice). The description of the EDI exchange requirement will be provided shortly. Any suggestions from suppliers are welcome and should be sent to the following mail address: nadja.malewski@zwilling.com.

#### 5. PROOF OF ORIGIN

For all delivered goods, you need to provide a proof of origin.

#### Accepted documents are:

Proof of origin for goods of the Federal Republic of Germany as well as for goods from the EU Member States

- Supplier's declaration / long-term supplier's declaration for products having preferential origin status according to regulation (EC) No. 1207/2001 (without cumulation).
- Certificates of origin for products without having preferential origin status, issued by an authorized agency.
- (Long-term) declaration IHK (CCI) for the non-preferential origin as per Council Regulation (EC) No. 2913/92 (CC) and Commission Regulation (EC) No. 2454/93 (IPC).

Proof of origin for goods of preference-giving countries (www.zoll.de)

- Original of preferential documents (e.g. movement certificate EUR.1/EUR-MED without cumulation, declaration of origin on commercial document, GSP/certificate of origin Form A).
- Supplier's declaration / long-term supplier's declaration Turkey according to decree No. 1/2006 of the EC-Turkey Customs Co-operation Committee of 26 September 2006 Annex VI.
- Certificates of origin issued by an authorized agency.
- (Long-term) declaration IHK (CCI) for the non-preferential origin as per Council Regulation
   (EC) No. 2913/92 (CC) and Commission Regulation (EC) No. 2454/93 (IPC).

Proof of origin for goods from other third-party countries

Certificates of origin issued by an authorized agency.

Please note that desired documentary proofs of origin have to be present before delivery.

#### PROCESSING FEES

The minimum processing fee for the following faults is  $\in$  100. In addition, the extra work will be charged based at an hourly rate of  $\in$  50.

#### **FAULTS**

- 1. The delivery note is missing / the delivery note does not match the consignment and the packaging label is missing.
- 2. The details on the delivery note are missing or are incorrect relating to the
  - Supplier
  - Delivery note number
  - ZWILLING purchase order number and order date
  - Purchase order item
  - Item description and item number
  - Delivery quantity
  - Number of Euro pallets, packages, grid boxes etc.
  - Delivery method
  - Dispatch date
- 3. The information on the package label is incomplete or incorrect.
- 4. Delivery on disposable pallets (unless specified by ZWILLING).
- 5. Delivery on defective pallets.
- 6. Euro Pool pallet is overpacked (weight, height, width etc.)
- 7. Euro Pool pallet is not secured or not stably packed.
- 8. Deliveries are not of a single-product type (depending on delivery volume).
- 9. Other infringements of the delivery instructions as from Status 2020.




